

# Township of Lake

Minutes of June 18, 2007

Supervisor Kelterborn called the regular meeting of the Lake Township Board to order at 7:35 P.M. Present were Kelterborn, Fischer, McCallum, Hyzer and Remer along with four guests. (Due to heavy storms, electric power was out.)

Minutes of May 21, 2007 approved upon motion by Remer, seconded by Fischer. Motion carried. Treasurer's Report approved upon motion by Hyzer, seconded by Remer. Motion carried. Agenda approved with the addition of the 2006-07 budget amendments, road tiling and trash burning upon motion by Fischer, seconded by Remer. Motion carried.

Correspondence read, including a letter from Oak Beach County Park residents regarding the lack of an on-site manager.

No petitions.

### **New Business:**

**Oak Beach County Park.** Motion by Hyzer to send a letter to the Road Commission expressing the Township's concern over the lack of a manager on site, seconded by McCallum. A copy of the letter received from the residents of Oak Beach will be included. Motion carried.

**Budget transfers.** Motion by Kelterborn to make the following budget transfers in the 2006-07 budget:

\$100.00 transferred from Election Salaries to Election Mileage

\$200.00 transferred from Contingency Fund to Maintenance (Inside/Outside)

\$700.00 transferred from Planning & Zoning Education to Planning & Zoning Consultants

\$120.00 transferred from Contingency Fund to Health & Welfare: Public Safety

Motion seconded by McCallum. Motion carried.

**Road tiling.** Motion by Hyzer to tile Conkey Road from Griggs Road west to the asphalt, seconded by Remer. Motion carried.

**Trash burning.** Discussion on complaints regarding burning of trash and action taken by the zoning administrator. Kelterborn will talk with the zoning administrator regarding enforcement on Bob Siver's complaint to the township of Feger's burning barrel.

### **Old Business:**

**Conkey Road tube.** Tabled.

**Septic Committee.** Committee still working on ordinance language for septic maintenance.

Motion by Remer to pay bills, including Visa bill for \$399.00, seconded by Fischer. Motion carried.

**Comments:**

Walt Kloc asked whether the Zoning Administrator's reports were available for inspection, specific to questions relating to blight in his neighborhood. Kelterborn advised him to visit the office during regular office hours to inspect the file.

Motion by Hyzer to adjourn, seconded by Remer. Motion adjourned at 8:25 P.M.
