Approval of Minutes

Old Business:

Recreational Vehicle Use on vacant property

Jeff Krohn took a seat away from the Board table and excused himself from discussion due to a conflict of interest regarding recreational vehicle use on vacant property.

Szumlinski stated that this Board has been discussing adding more days to Lake Township's ordinance and splitting the year into quarters. He suggested the following:

Jan., Feb, March April, May, June July, Aug., Sept, Oct., Nov., Dec.

Each quarter would have 18 days available for recreational vehicle use with a special use permit.

Krueger agrees.

Golsch offered that his concerns with this are the sanitation issues. Also, should the Board consider adding something regarding primitive camping?

New Business

Use of Firearms

Szumlinski referred to the document in the member's packets titled Sheridan Township Firearms Discharge Ordinance and that this document was copied and made specific to Lake Township. He stated that this was for review only. He added that recently there was an incident on Sand Road and Quarry Road in which some individuals were shooting in the late hours disturbing neighbors. Law enforcement officers were not able to do anything regarding this situation. It was suggested

that perhaps if Lake Township had an ordinance in place regarding the use of firearms, this could be easier to enforce.

Szumlinski added that he was suggesting to this Board that the members look over these documents and see if this is something that would benefit Lake Township or if it should be amended by adding or deleting items.

Motion by Hartsell, to table Use of Firearms, seconded by Krueger. All Ayes. Motion carried.

Public Comments

Mike Bilkie commented that he does not agree with restricting the use of firearms in Lake Township.

Tory Geilhart commented that as a long time resident (34 years) of Lake Township, he is appalled that this township would draft or even consider an ordinance that would affect the people's 2nd amendment right to bear arms all because of one incident. He added that this issue should be tabled and not addressed again.

Richard McIlhargie commented that if he understands the situation correctly, the individuals shooting the guns, their property borders state land.

No more public comments.

Szumlinski asked the Planning Commission members if they had any discussion on the use of firearms issue.

Hartsell stated that he feels Lake Township should not touch this issue.

Krohn stated that he did not accept his appointment to the Planning Commission to adopt new ordinances, he feels the Lake Township's Zoning Ordinance need to be gone through and updated.
