**Land Use Permit Review:** Building and Zoning Administrator, Tory Geilhart and the Planning Commission members reviewed the following Land Use Permit Applications.

- 6631 Van Rd; addition of outdoor storage closet (attached to back of house); 80 sq. ft. floor area.
- 5932 Dufty Rd; 12X18 addition on existing shed; 216 sq. ft. floor area.
- 3958 Port Austin Rd; replace existing porch with wooden (deck style) porch having two (2) sets of stairs giving easy access to house and driveway.

The PC members recommended that Geilhart approve the Land Use Application submitted for the Dufty Rd. property. There were no other recommendations made.

**Draft Zoning Map Review:** Upon reviewing the Draft Zoning Map in conjunction with the comments submitted by Mark Eidelson, the PC members have decided to move forward toward finalizing the Zoning Map with Huron County Tax Mapping. All of Eidelson's recommendations will be included.

- Chapter 1, pg. 1-5, Column 2, Paragraph 3: Should read "Police protection services are provided by the **Huron** County Sheriff's Department...
