Petitions/Public Comments – Ben Seago of APM Mosquito Control made presentation to the township board in regards to mosquito control options available. Application was explained and the chemicals used was discussed. No quotes were given.

Old Business

Quarterly Budget Review – A motion was offered by Deming, supported by Kelterborn, to table budget review of Department 702, Zoning Administrator, until November meeting to allow reassignment of ZBA line items in the new software. All in favor, motion carried.

A motion was offered by McCallum, supported by Kelterborn, to add \$100 to Line Item 101-371-860-000, Building Inspection Mileage, from the General Fund. All in favor, motion carried.

Lake Road – Our Township Attorney sent a letter to the Huron County Road Commission concerning the authority over Lake Road. Some disagreement concerning responsibility for the road exists. During a meeting between the Township Supervisor and Neal Hentschl, Huron County Road Commission Manager, Mr. Hentschl suggested the Board pass a resolution requesting Lake Road be made a public road. The effect this could have on the adjoining property owners was discussed and it was suggested the Board seek the property owner's input before taking action, A motion was offered by McCallum, supported by Collins, to table action on Lake Road until an equitable solution could be formulated. All in favor, motion carried.

Ordinance Enforcement – Zoning Administrator, Tory Geilhart, addressed the board in regard to several issues that have arisen regarding the Zoning Ordinance adopted in November 2020. As is normal, when a new Zoning Ordinance is adopted, review should take place 1-2 years after adoption to address any unforeseen issues created by the ordinance. The board stated the Zoning Administrator is to prepare suggestions in writing for Planning Commission meetings to discuss any amendments to the Zoning Ordinance in regard to any issues that have come to light during the administration of the Ordinance.

New Business

Land Division Ordinance – A motion was offered by Kelterborn, supported by Collins, to table the Land Division Ordinance review until the November meeting. All in favor, motion carried.

CAFPA – The Caseville Area Fire Protection Agency recently received a grant to be used for air packs. To service the air packs, a new air compressor is required at the cost of \$60,000. Any CAFPA purchase over \$25,000 must be approved by the member organizations. A motion was offered by Collins, supported by Kelterborn, to approve the air compressor purchase. All in favor, motion carried. **Payment of Bills** – After review, a motion was offered by Collins, supported by Kelterborn, to pay the bills as presented. All in favor, motion carried.
