Beach Grooming

Legislation was recently passed by the Michigan Senate that will allow beach front property owners to groom their beaches without securing a permit from the MDEQ. If SB 1052 becomes law, shoreline property owners will still be required to get a permit from the U.S. Army Corps of Engineers (USACE) for beach grooming below the ordinary high-water mark elevation. USACE applications are available at the Township Hall or on line at:

Lake Township's Wind Ordinance update...

In February Lake Township voters turned down the Lake Township Wind Energy Facility Overlay Zoning Ordinance 207 to 128. On May 4, 2012 a letter was submitted to the Lake and Chandler Township Boards by Okemos Attorney William Fahey on behalf of several Lake Township property owners requesting a conditional transfer of their property based upon PA 425 of 1984. At the May 21st meeting of the Lake Township Board a motion was made by Supervisor Smith to consider entering into a PA 425 agreement with Chandler Township. The motion was seconded by Fischer and passed by a 3 to 2 roll call vote. Fischer then made a motion allowing Supervisor Smith to appoint three persons to meet with Chandler Township representatives to discuss the advantages and disadvantages of a PA 425 agreement. Fischer's motion was seconded by Osborne and also passed by a 3 to 2 roll call vote. Smith appointed himself, Trustee Osborne and Planning Commission Chairman Paul Golsch.

On Monday, June 4 Chandler Township voted unanimously not to enter into negotiations with Lake Township and advised Supervisor Smith at that time that they were not interested in participating in a 425 agreement.

If you have questions or concerns regarding this issue, you are encouraged to attend Lake Township meetings. The Planning Commission meets on the 4^{th} Wednesday of the month at 7 PM and the Board of Trustees meet on the 3^{rd} Monday at 7:30 PM.

A burning permit is required if you are going to be burning leaves and tree trimmings. Call the Fire Department at **989.856.9198**. Leave your name, address, phone number and scheduled date of burning. It is illegal to burn garbage pursuant to Lake Township General Ordinance 2005-01. ORV ORDINANCE

It is **unlawful** for anyone under the age of 12 years old to operate an ORV on Huron County Roads. Also, ORV's are **prohibited** on M-25. Golf carts are considered ORV's and should avoid this highway. The use and enforcement of ORV's in Lake Township falls under the jurisdiction of Huron County and all matters are handled by police and DNR agencies.
