# **Lighting Ordinance Adopted**

Ordinance No. 2015-02 was adopted by the Lake Township Board of Trustees on April 20, 2015. This ordinance came about after several complaints of intrusive outdoor lighting from neighboring properties.

The intent of this ordinance is "to prohibit light trespass and afford the citizens of Lake Township the flexibility to engage in the pursuit of safe, inexpensive lighting practices for the purpose of commerce and private use without impeding upon other citizens desiring a more pristine night time environment free from light pollution, waste, or nuisance while providing for security and productivity." # **Garage Sale Ordinance**

Ordinance No. 2015-01 amends our previous garage sale ordinance. Permits are still required but there is no permit fee. Failure to apply for a permit, on the other hand, will result in a municipal civil infraction and costs. Permit applications are available at www.laketownship.net or at the Township Hall during regular business hours.

# **Home Security Systems**

If you have a home security system that calls 911 in the event of an alarm, you should have a key available locally for the fire department or local police, especially in cases of false alarms. Police response could be hampered by the inability to enter the premises and false alarms that bring out the fire department are not only costly, but could cause a delay to a real emergency.

#### **New Recycling Program**

Lake Township residents can now drop off their recyclables <u>every week</u> during regular Transfer Station hours. Acceptable items have changed slightly. A list of what is accepted is available at the Transfer Station or at www.laketownship.net. Items do not need to be sorted; just clean, dry and caps removed. 22 gallon recycling bins are also available for \$7.75 at the Transfer Station or the Township Hall.

#### **Personal Watercraft / Boat Hoists**
