## RECYCLING

The recycling trailer is packed full every month as more residents are choosing to recycle, helping us do our part in reducing the amount of trash deposited in our local landfill. Our recycling program is operated by volunteers. Without our volunteers we couldn't offer this service to our residents.

We need at least four volunteers every month and would really like to add some new names to our list. If you have any interest in getting involved, please contact the Township Hall at 856-4867.

If you choose to recycle, here are some requests:

- 1. Rinse all containers and remove all caps and lids.
- 2. Do not put boxboard, cardboard or any other materials in with newspapers.
- Bag or tie all newspapers, magazines, office papers keeping them separate from each other.
- 4. Keep plastic shopping bags separate from other plastic screw top bottles and jugs.
- 5. Glass bottles and jars should be clear. No green, brown, blue glass
- 6. Bring clean and dry materials only.

## SECURITY

We urge our residents to become more security conscious. Last winter there were an increased number of break-ins no doubt due to the poor economy. We suggest that all seasonal residents refrain from leaving valuable articles such as jewelry, firearms, or expensive electronics in their home or cottage when they leave for the city or take a vacation. If it is impossible to remove such items, try to make arrangements with a nearby resident to check on your home. Depending on how long you will be gone, it might be a good idea to have some snow removal done to make thieves think you are in residence. Lighting timers are inexpensive and several well timed intervals can help give your home a lived in look.

We hope the trend in break-ins will not continue or accelerate, but if it does, do not make it easy for the thieves.

#### **BURNING PERMITS**

A burning permit is required if you are going to be burning leaves and tree trimmings. Call the Fire Department at 989-856-9198. Leave your name, address, and phone number. It is illegal to burn garbage pursuant to Lake Township General Ordinance 2005-01. Burning trash is unhealthy and harmful to our environment and your neighbors. The ordinance is posted on our website if you want more information. There is no fee for a burning permit.

## **BOAT HOISTS**

Boat hoists must be registered and cannot be stored on the easements at any time. Snow fences must also be removed until October 1<sup>st</sup>. Please contact Arnie Russell, Zoning Administrator for further information at 989-856-4867.
