#### WIND ORDINANCE .....

The Lake Township Board of Trustees, at the meeting of June 20, 2011, adopted the Wind Energy Overlay Zoning ordinance (by a vote of 4-ayes/1 nay). This overlay was recommended by the Planning Commission.

- July 6, 2011, a notice of intent to file a petition for referendum was received by the Lake Township Clerk.

July 27, 2011, nine pages of 102 petition signatures were received by the Lake Township Clerk.

### COMMENTS REQUESTED

The Lake Township Planning Commission at it's last meeting of November 16, 2011, began discussions on the ordinance governing the dimensions of accessory structures in the **Rural Residential District**. Current zoning allows maximums of: 1728 sq. ft. floor space, 12 ft. high side walls, and a ridge height of 21 ft. Some members of the commission feel this may be too restrictive and should be amended.

Your comments on this matter are requested and should be submitted by January 20, 2012, for the next planning commission meeting on January 25, 2012, if you are a property owner in Lake Township. You may also attend this meeting in person. Respectfully yours,

#### From the Clerk's Desk....

Next year, 2012, will be a big election year beginning on February 28, 2012 with a presidential primary. On that date Lake Township voters will also have an opportunity to vote on the Wind Ordinance adopted by the Township Board on June 20, 2011. The wind ordinance is available for review on the township's website, <u>www.laketownship.net</u>.

Elections for township offices as well as county and state offices also occur in 2012. Persons interested in running for office may contact me at 989.856.7485 for nominating petitions and forms or they can be picked up from the County Clerk's office.

For voters interested in receiving applications to vote by absentee ballot, an application is available at <u>www.laketownship.net</u> under *Elections*.

Also available on the township website under *Elections* is a form you can return requesting your name be added to a permanent **absentee voter list.** By submitting that form, you will automatically be sent an absentee ballot **application** for each individual election (which you can then return if you wish to vote). <u>A ballot will not be sent to you unless the application specific to that election is returned.</u>

For the August Primary and November General elections, any voters on the permanent absentee voter list will receive a single application for both elections. This application needs to be completed for both elections in order to receive a ballot for each election. Please complete the application <u>in its entirety</u>, checking the appropriate boxes for either or both elections. If you have any questions, please feel free to contact me at 989.856.7485.
